

# HIGH COUNCIL DECISION N. 03/2022

of 05 September 2022

**determining the categories of persons to whom  
the provisions of Articles 9 to 12 of the Protocol  
on the Privileges and Immunities of the European  
University Institute shall apply**

## THE HIGH COUNCIL

Having regard to the Convention setting up a European University Institute (hereinafter the “EUI” or “the Institute”), in particular Article 4;

Having regard to the Protocol on the Privileges and Immunities of the European University Institute, in particular Article 13;

Having regard to High Council Decision No. 3/78 of 31 May 1978 determining the categories of persons to whom the provisions of Articles 9 to 12 of the Protocol on the Privileges and Immunities of the European University Institute shall apply, in whole or in part;

Having regard to High Council decision No. 10/2020 of 15 December 2020 Rules of Procedure of the High Council, in particular Article 7;

## Whereas:

- (1) According to Article 8 of the Headquarters Agreement, the Italian Ministry of Foreign Affairs issues special identity cards to the persons referred to in Articles 9 and 10 of the Protocol on the Privileges and Immunities of the European University Institute, who are designated by the Italian Republic in application of Article 19 (2) of the Protocol and who do not have Italian nationality;
- (2) The Protocol on the Privileges and Immunities of the European University Institute foresees the possibility, in Article 13, to specify the categories of persons to which the provisions of Articles 9 to 12 should apply;
- (3) It is desirable to update the categories of persons to whom the provisions of Articles 9 to 12 of the Protocol on the Privileges and Immunities of the EUI shall apply according to HC Decision 3/78;

- (4) The Protocol on the Privileges and Immunities itself already defines the relevant categories, and therefore an additional decision of the High Council is only needed to specify these already mentioned categories.

**HAS DECIDED AS FOLLOWS:**

*Article 1*

The categories of persons to which Article 9 (1) d of the Protocol on the Privileges and Immunities of the European University Institute shall apply are as follows:

Principal, Secretary, teaching and other staff of the European University Institute, with the exception of:

- those who at the time of recruitment had their permanent residence in Italy;
- teaching and other staff with less than one-year contracts.

*Article 2*

The categories of persons to which Article 10 of the Protocol on the Privileges and Immunities of the European University Institute shall apply are as follows:

- a) Research students, including other categories assigned to research activities.
- b) The members of research students' families forming part of their households.

*Article 3*

This Decision enters into force on the date of its adoption.

This decision repeals with immediate effect High Council Decision No. 3/78 of 31 May 1978 determining the categories of persons to whom the provisions of Articles 9 to 12 of the Protocol on the Privileges and Immunities of the European University Institute shall apply, in whole or in part.
